In February of this year I received from London Borough of Lewisham a copy of my Social Services notes. I had been a service user due to my arthritis and need of assistance looking after my baby daughter. I was dismayed to find that a Social Worker, Richard Hodgkiss, from the children's Department had been "regularly" viewing my Facebook page and other internet activity. In response I wrote an email to Mr Hodgkiss, copying in some 500 of his colleagues and local councillors. In this email, I joked that "this isn't care, it is surveillance". Mr Hodgkiss must have been very angry and embarrassed by the email, because he sought revenge by involving the Police Child Protection Unit and actually putting me under police surveillance. The pretext for

doing this would have been "mental health issues" though I have never been diagnosed with any such issues. Having been under surveillance nearly a year at this point, I have not yet been arrested or sectioned. Given the stress I have been placed under, you can draw your own conclusions that I am a very strong and mentally healthy individual!

I first became aware of the surveillance when I returned from shopping one Saturday to find a blank CD broken in two and stuffed behind a cushion on my sofa. Since my daughter was then only 3 years old and neither of us are strong enough to snap a CD in half, I was left to conclude that somebody had entered our home and done this. There were no signs of break-in.

Since then, several more items have been broken and others removed:

- Various computers broken and tampered with, including one which is my home music studio. The casing on one of my laptops has been cracked.
- · Adapter for an Android notebook, broken.
- Casing on power supply for ioniser, cracked.
- Dishwasher, broken expensive item and much needed since I have a disability.
- 2 pairs of Turkish trousers, recently repaired (repair mentioned on Facebook) sewing unpicked.
- Wooden crucifix, taken then returned a few weeks later.
- Financial documents, taken **never returned**.
- Daughter's "Red Book" (record of vaccinations), taken **never returned** disappeared prior to visit from Social Worker.

I have had to report my mail being tampered with to Royal Mail. In addition to this, certain items never arrive. When purchasing items online, they often arrive broken, or essential parts missing. The latest of these being a CCTV surveillance system which arrived without a power supply.

My mobile phone is being hacked, such that I never receive certain text messages. The most significant has been the following:

- Text message from a Health Visitor wanting to make an appointment. I never received the text and so the lady just arrived on my doorstep when I was not expecting her.
- Reminder texts from GP / hospital never arrive. This has meant I have been discharged from my rheumatologist at Guy's hospital for missing an appointment. Neither did I receive any letter regarding the appointment (they often send letters changing the appointment date).

My computers and email communications are being tampered with to an extent where my human rights are being affected. I currently have no right to free speech given I am unable to upload videos to YouTube. I am also unable to view my medical records online despite having made several complaints to the Practice Manager at my GP surgery. My daughter and I regularly witness the mouse pointer on my laptop moving around on its own and when I try to shutdown the computer, I get messages warning me that "Other users" are logged onto it.

There is also evidence that our home is bugged, given the reading on an electromagnetic field meter, which reads 1,450 nT in the proximity of our gas boiler. Gas boilers do not emit radio frequency waves as they are not a broadcasting device – but a wireless bug is. If the police have legitimate reasons to be concerned about me, they have had almost a year in which to surveil me and have not taken any action. The way I am being treated amounts to bullying – of a disabled, single mother. There is absolutely NO EVIDENCE of my "mental health" being a serious issue in terms of my being a risk to myself, my daughter or anybody else. I would like compensation for the items I have had damaged and removed, plus an apology for the damage done to my reputation given that many of my friends have (apparently) been contacted and lied to about me. It is an outrage that taxpayers' money has been used to harass an individual whose life is difficult enough in the first place.
